facilities, reprocessing, and mixed-oxide fuel use.



### Dry Storage in the U.S.

The StoreFUEL and Decommissioning Report was created to assist utility fuel managers, cask designers, fabricators, and other related companies in staying current on the U.S. Nuclear Regulatory Commission's (NRC) certification process for spent fuel cask technology. StoreFUEL, published the first week of every month, also includes U.S. cask

vendor licensing activities, a brief summary and detailed tables of all active and planned dry storage programs in the U.S., and updates on shutdown reactors and other decommissioning activities in the U.S.
